

Dr Shaunna, Meal Cure and The Health Professional Academy ("THPA") Terms of Use, Privacy Policy, and Intellectual Property

1. GENERAL CONDITIONS

a. Acceptance of Terms. By accessing Dr Shaunna, Meal Cure and THPA family of websites, including www.drshaunna.com and other Dr Shaunna, Meal Cure and THPA owned websites, including but not limited to thehealthprofessionalacademy.com, www.drshaunna-apply.com, freetohealdownload.gr8.com and mealcure.com collectively, the "Site(s)", you agree to be bound by the terms and conditions described herein ("Terms of Use") and any subsequent changes, as it may be updated from time to time. Except as specifically stated otherwise, these Terms of Use set forth the entire understanding relating to this subject matter.

b. Severability. If any provision of the Terms of Use is held to be invalid or unenforceable by any law, rule, order, or regulation of any government or by the final determination of any state or federal court, all remaining provisions hereof will remain in full force and effect.

1st Party Cookies
